2020 Team Priorities Review

Mental Health Court

Exploratory subcommittee in 2020. Released report in November with recommendations and summary. Judge Chesser felt that there were not enough individuals with mental health disorders coming to St. Mary's District Court who receive longer-term sentences, part of the criteria for mental health court, which is a 1-2 year program. Agrees that there should be a follow up or care coordination for the individuals who do have mental health disorders.

Youth Mentoring

- Minimal response to survey. Promote free trainings from Maryland Mentor.
- Youth Mental Health First Aid (for adults) and Teen Mental Health First Aid (for high school) offer to local mentoring programs.

Crisis Services

- SMC awarded \$200,000 to get RFP to assess crisis service needs for the tri-county region
 - RFP to come soon.

2020 CHA Data Review

- Average mentally unhealthy days in the past 30 days indicated by adults 3.6
- Rate of emergency department visits related to mental health conditions (per 100,000) 6,173.1
- Middle Schools students reporting feeling so sad or hopeless almost every day for 2 weeks or more in a row that they stopped doing some usual activities in the past year - 22.2%
- High Schools students reporting feeling so sad or hopeless almost every day for 2 weeks or more in a row that they stopped doing some usual activities in the past year - 33.6%
- High School students who currently drank alcohol (at least one drink of alcohol, on at least 1 day during the 30 days before the survey) - 30%
- High School Students who reported binge drinking (on at least 1 day during the 30 days before the survey) - 17.2%
- Percent of Adults Who Had At Least 1 Drink of Alcohol in the Last 30 Days 50.9%

- Qualitative coping mechanisms used across the age ranges, preventative care (look at it by age groups)
- Prescription Medication Costs & Medication Compliance
- Law Enforcement Data EPs, offenses related to drug use/overdoses, wellness checks
- Social Services Data
- EPs who are admitted vs. released (continuity of care)
- Number of individuals who are scheduled for services (MH/SUD) with local providers but who never engage and why
- Ratio of single interaction individuals and how many are repeated EPs

- Saw some spikes in overdose rates and non-fatals in 2020. Prevention team working with HRP to do outreach. They have lockboxes with narcan that are available to dispense in the community. Reach out to Maryellen for more information.
- Alcohol use skyrocketed last year during the pandemic. CAC meeting monthly and also presented to the alcohol beverage board recently. New bill proposed this year for "to-go" alcohol at restaurants.
