



ADVOCACY AGENDA

Access to Care

- A local or regional transportation hub or system that provides coordination across multiple transportation options
- Expansion of public transportation options (e.g., extended, schedules, additional routes, increased frequency, connector options, etc.)

Healthy Eating & Active Living

 Smart Growth and Complete Streets policies within local regulations and processes

Behavioral Health

- Financial incentives and regulatory changes to better recruit and maintain behavioral health providers
- Improved organizational policy in the local school system to expand access to behavioral health services for youth

Tobacco Free Living

 Assist local businesses and organizations with drafting and implementing tobacco-free policies

Access to Care Action Team

- Working with the Tri-County Council on a regional project to expand access to healthcare through innovative transportation solutions
