- 2. RU Ok? Presentation**
 - a. Maryellen presented on the new suicide prevention outreach campaign 'RU Ok?' You can view the presentation is available [here](#). They are looking to do a kick-off event around November along with a guest speaker – Jordan Burnham.
- 3. Objectives & Goals for 2018 Team Priorities**
 - a. Appropriate ER Utilization for Behavioral Health
 - i. The group is looking to gather both quantitative and qualitative data from the hospital. It was discussed that the group is looking to see how many people are relying on the ER for care instead of a primary care physician and what resources are being provided at discharge. Tammy and Jacquie will reach out to those who expressed interest in being included in the meeting with ER staff to set up a BHAT subgroup. This subgroup will discuss the data we would like to have pulled, choose representatives to meet with staff at the hospital to see what data is possible to pull, and work to gather qualitative data from ER staff. The subgroup gather data and present it to the whole Behavioral Health Action Team.
 - b. Youth Suicide
 - i. AFSP has several upcoming events.
 1. They will be showing the It's Real video and doing a Talk Saves Lives training at the Leonardtown Library on August 27. They will also be doing the same event in September at the Lexington Park Library.
