2. **Updates: Policy/Advocacy Initiatives**
  - a. Goal: Increasing the number of tobacco free environments
    - i. Smoke Free Holy Grounds
      1. There will be a meeting with Bishop Thomas and Lawrence Carter about Smoke Free Holy Grounds on December 12 from 10:00 a.m. – 12:00 p.m. at the St. Mary's County Health Department. Any interested coalition members are encouraged to attend.
3. **Cancer Screenings Program Update**
  - a. The Breast and Cervical Cancer Program (BCCP) and the Colorectal Cancer Program have merged and are receiving Cancer, Prevention, Education, Screening, and Treatment (CPEST) funding. There has been a decreasing number of clients over the past couple of years; however, due to the translator being available at the SMCHD Clinic the Hispanic community has recently started utilizing the program. Cathy now has a waitlist for the BCCP. The program provides screening services and will help connect a client to services for care when necessary. Cathy is attending meetings at the Hospital with and will be connecting with Calvert County to gain insight on their successful outreach efforts. 4. **GMHS Youth Engagement Project**
