2020 CHA Data Review

- Since 2010, 12 water systems in St. Mary's County have had violations of the Safe Drinking Water Act
- Chesapeake Bay Report Card 2020: C-
- Average daily air particulate matter (in micrograms per cubic meter): 9.6 (2014)
- Respiratory hazard index score: all census tracts <.42 (2014)
- Renters that are cost-burdened: 39.5%
- Households that are considered to have severe housing problems: 28.2%
- Residents that do not have a vehicle available to their household: 7.4%
- 3 food desert census tracts
- Percent of Households Below the Poverty Threshold: 7%
- Percent of Households Below the ALICE Threshold: 24%
- Homeless individuals in SOMD: 399 (2020)



MD SHIP Environmental Health Data Measures

- Children Receiving Blood Lead Screening - This indicator reflects the percentage of children (aged 12-35 months) enrolled in Medicaid (90+ days) screened for lead in their blood.
- Affordable Housing - This indicator shows the percentage of housing units sold that are affordable on the median teacher's salary.
- Children with Elevated Blood Lead Levels - The legal definition of an elevated blood lead level in Maryland is 10 micrograms/deciliter (mcg/dL), but the current CDC and Maryland guidelines for health care providers urge follow up for any child with a level of 5 mcg/dL or higher.
