- The Family Education Subcommittee was formed to discuss and implement effective and preventive approaches to reduce youth mental health crisis emergency visits

- Update from subcommittee for Mental Health Court
 - Maryellen and Kristen reviewed the 2020 Summary Report and agreed that a subcommittee is worth pursuing
 - They will work on the next steps which include following up with report recommendations, updating the data, reviewing solutions and funding, and discussing with the District Court Administrative Judge

No Shows

- Suggestions from the last meeting were added to our sample <u>Client Letter</u> for providers. The next step is to it send over to language services to be translated into Spanish!
- Thank you for sharing the Assessing No Shows <u>Survey</u> and <u>flyer</u>!
 - 20 responses were collected
 - Common reasons for missing behavioral health appointments were transportation issues, and that they forgot or had scheduling conflicts (e.g., work)
 - Because of the small sample size, the results are inconclusive, but it gives us an idea of the barriers individuals face
- Transportation Advisory Council is currently analyzing its data from its STS survey. They should have its full report released by July 20
- How well does the community know about our transportation resources?
 - There was a discussion on transportation options to/from health services (Uber rides, cab services, health programs that offer transportation, gas vouchers)
 - We will reach out to <u>SMCHD's Medical Assistance Transportation Program</u> for data on no shows

Health Equity
