Partner Updates

- The **YMCA** <u>broke ground!</u> The grand opening is set for Spring/Summer 2026.
- Inner Peace Therapeutic Services now has 5 providers who accept Medicaid!
- QCI Behavioral Health are now accepting patients in mobile treatment and outpatient services. Mobile treatment has multiple services and travels to where the person is (including those who are unhoused). Transportation can be provided to see providers in office.
- The **Homeless Prevention Board** hosted Community Resource Day on November 13! Over 165 families were served! This year was held in the afternoon, to great success.
 - HSMP's VIT Action Team created 100 bags that were distributed, containing toiletries and essential items.
- Maryland Coalition of Families: There are 4 peer support specialists in the county, 3 are directly connected with the schools. Free virtual <u>support groups</u> aimed at families of children with behavioral health challenges are available.
